3. Safeguarding Statement of Compliance

The Safeguarding Statement of Compliance was presented to council members present.

4. Presentation of the Electoral Roll

5. Presentation of the Annual Accounts

PCC members thanked Mick for his work during difficult times and everyone who has done work for the Church. Mick commented on the 'tricky road ahead' and changes that will have an impact on the benefice. He noted the importance of the Lay Ministry at ESM and the bigger challenge at ASB with Lindsey Littlewood, Mary White and Tom Fryer all moving out of the area. This leaves ASB most vulnerable and Mick asked for prayers for both Churches.

In chapters 2 and 3 of the book of Revelation, right at the end of the Bible, God gives John a report on the seven churches of the region.

Each report carries the same opening phrase 'I know your deeds'! God goes on to highlight some strengths and weaknesses of each church

There is something of that process going on as we write our various reports covering the life and witness in our parish. This process takes on a bigger significance as the Benefice moves into a vacancy.

As a benefice we will have to write a 'Parish Profile' this will involve looking back and saying, this is where we have come from, this is what we are doing well and this is where we are struggling.

We will then need to say what our collective hopes are for the future and what sort of person might be best equipped to lead us – the Archangel Gabriel is unavailable!

As I read the various reports, there is much to celebrate across the Benefice.

Thank you to everyone who has taken time to produce a report and to everyone whose time and energy gives something to write about!

Once again, I want to name our three churchwardens, Simon Branton; Derek Reynolds and Geoff Ogden, the three of them have continued to serve faithfully and effectively despite each one of them facing their own personal challenges, gentlemen I salute you.

I am also grateful to those who have stepped up to the plate when our wardens have needed help.

The financial situation still offers the greatest challenge to the future of our churches locally. Although we are not paying our way [funding a vicar's post] the Diocese have seen enough to agree to replace me when I retire this summer. That appointment may well come with conditions and be time limited as the Diocese cannot continue to subsidise our ministry at the rate they are doing – funds are running out.

We will only be able to overcome the financial challenge by increasing our income. This will probably only happen if one or all of the following happens.

- 1. Our regular congregation gives more money to the church as a regular, prayerful, committed offering.
- Our buildings are able to be used to draw in an income stream that more than covers our costs.
- 3. That we see more people coming to faith and joining our active, worshipping, serving community that is, to make disciples.

For sustained growth the most effective option is the third one!

It is not only effect for securing the churches future it also meets the challenge given to each one of us by Jesus himself as recorded on Matthew 28

Then Jesus came to them and said, 'All authority in heaven and on earth has been given to me. **Therefore go and make disciples** of all nations, baptising them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you. And surely I am with you always, to the very end of the age.'

Making disciples begins with us. Still the most effective way of bringing people to faith is through personal invitation and example. For your friends and family, you are probably the only advert God has!

Looking forward, perhaps do three things.

- 1. Draw up a short list of people you would like to see come to faith in Jesus and begin praying regularly for them.
- 2. Look for opportunities to share your faith story with them

3. Look for opportunities to invite them to something church is putting on or even a Sunday service.

In truth this action has been going on for some of you and doesn't need to wait for a new vicar to come in, why couldn't our church grow during a vacancy?

Safeguarding Report

Paul Shepherd

The Parish's Safeguarding commitments continue to be ably supported with both Paul Shepherd and Debbie Goodwin acting as Elloughton Cum Brough Parish Safeguarding Representatives. Geoff Ogden, our previous PSR continues to provide valuable support and guidance in his role as DBS checker and Lead Recruiter.

Our Safeguarding Policy, in line with the National Parish Safeguarding Handbook is being refreshed and will be circulated shortly for approval by the PCC.

Paul and Debbie's tenure has continued to focus on responding to The Church of England's directive for the Parish to complete and renew Safeguarding training.

The training is essential to demonstrate the Parish's commitment to Safeguarding and raising awareness about this subject to protect children and vulnerable adults within our care. The training audience includes all the paid and voluntary roles within the Benefice, mainly accessed online, and has been previously completed by over 40 people within our congregation. Two people have been processed through 'Thirty One: Eight' this year for DBS's (Disclosure & Barring Service).

However, the focus for 2023 is for our congregations to renew Safeguarding Training. 7 people have renewed their training in the past 12 months or completed it for the first time, with a further 13 people due to be renewed during the coming year.

Thank you to everyone who responded so quickly to the training requests. Debbie also deserves a special mention for co-ordinating the training.

Face-to-face training for our Sides people and Refreshments Team without access to the online materials was delayed by the pandemic. We are grateful that the Diocese of York Safeguarding Team have recently created training materials for Basic Awareness and Foundation pathways and scheduled local training events. As such, 7 people from our churches are now scheduled to attend face to face Safeguarding training at South Cave Church Hall on Saturday April 29th April. The remaining gap for the Benefice to complete in the coming months is to produce Job Descriptions for the paid and voluntary roles.

Safeguarding ' Due Regard' Statement

The Parish of Elloughton & Brough Parochial Church Council responsible for St Mary the Virgin Church Elloughton, All Saints Church, Brough and St Mary's Hall, Elloughton has complied with the duty under section 5 of the Safeguarding and Clergy Discipline Measure 2016 duty to have due regard to the House of Bishop's Guidance on Safeguarding Children and Vulnerable Adults. This statement reflects the following action that has been taken over the year:

Safeguarding Policy. The Parish Safeguarding Representative is in the process of reviewing and refreshing a Safeguarding Policy for the Benefice reflecting all aspects of the House of Bishop's Promoting a Safer Church Policy Statement. The amended policy will be circulated shortly for approval by the PCC with copies displayed in both churches and St Mary's Hall,

Elloughton. It is also on the Benefice website. All staff and volunteers working with children or adults at risk have their own copy in booklet form.

- Safe Recruiting, Support and Training. All church officers including members of the PCC and others who work with children or vulnerable adults have completed confidential declaration forms and where appropriate have been cleared through the Disclosure and Barring Service, 17 in total. Two officers or volunteers in the parish have been processed over the year through the CCPAS online system. The Assistant Recruiter assists with processing the online applications The Safeguarding Representative circulates regularly to all staff and volunteers safeguarding updates from the Diocese of York, CCPAS, NSPCC, East Riding Safeguarding Children Board and East Riding Safeguarding Adults Board. A full programme of training has commenced for all staff and volunteers to complete the appropriate level of training through the Diocese from Basic to Leadership with specialist training as required depending upon their responsibilities.
- Responding to Safeguarding. An environment has been created which is welcoming and respectful thus enabling safeguarding concerns to be raised and responded to openly, promptly and consistently.
- · Hiring of Church Premises. Hire agreements for St Mary's Hall include the provision whereby the person/body hiring the premises agrees to comply with the Parish Safeguarding Policy or have their own and that those involved have appropriate DBS clearance if they are working regularly with children or vulnerable adults.
- Review and Progress Reports. Safeguarding is a substantive agenda item at all PCC meetings and written reports are prepared by the Safeguarding Representative. Referrals There have been no formal safeguarding referrals over the year to the Diocese of York or local safeguarding children and adult teams.

Church Wardens Report [St.Mary's Elloughton]

Ministry

The service structure of 2 communion services a month and one lay led Morning Prayer has settled down with the congregation accepting that there is no service on the 2nd Sunday, albeit there is a service of Holy Communion at All Saints, Brough on that day.

The service of Morning Prayer on the 4th Sunday led by members of the congregation continues to work well. There is a strong team of readers for the lessons and intercessions with myself and John Robinson leading on alternate 4th Sundays. I warmly thank all members of the team who assist in any way at this and the other services.

We are well supported for music at our services by our two organists, Richard and Caroline who choose the hymns reflecting the church season and lectionary. It has been commented that the acoustics of the church building for our music has improved since the removal of the carpets and new stone nave floor.

It has been good to welcome both Brownie packs to church again for the new style Parade Services. These follow visits by Mick to help them prepare and feel more involved in each service.

Mission

St Mary's remains an open church with church members operating a rota system to open and close it throughout the day until dusk. This is appreciated by visitors who are increasing in number. They particularly welcome the fact that the sensor lighting is activated as they enter, and lots of information available about the church. Very often visitors will include people tending graves but we have had visits recorded from others who have an historical family connection or those who simply wish to rest, reflect or pray quietly in a lovely peaceful setting.

The services at St Mary's are renowned for the fellowship after the service with tea/coffee and lots of chat which often lasts for a further hour. Thanks again go to the team of ladies who provide and serve refreshments.

On the first Sunday of the month following the Service of Holy Communion Jean arranges Sunday lunch at the Half Moon Inn. This is extremely well attended with numbers growing and it is much appreciated by everyone who attends.

St Mary's was decorated by our fantastic flower arrangers to celebrate the Diamond Jubilee of her Late Majesty Queen Elizabeth in June with a special service. The bell ringers gave a peel of the bells, the Union Flag was flown on the new flag pole with this activity linked to other events in the villages and at All Saints Brough.

A tree was planted in St Mary's churchyard as part of the Queens Platinum Jubilee Green Canopy.

Very Sadly on the death of the Queen on 8th September just over 3 months later the church once again responded. Within an hour of the announcement James and Alister were involved in a toll of the bells, the Union Flag was lowered to half-mast and a Book of Remembrance for her late Majesty was placed in the church for visitors to sign and add their tributes. The flag and bell activity continued on 11 September with a peel of the bells rung and flag raised to full mast as the formal Accession to the Throne of King Charles was celebrated for a few hours before the period of mourning continued. Thanks go again to the whole team led by Mick who responded so quickly. During the period of mourning over 100 people from the villages and wider afield visited the church to pay their tributes to her Late Majesty. It was wonderful that our parish played an essential part in supporting people in their grief and remembrance including special services during September.

Maintenance

There is always work to be done in such an ancient church. Following extensive work the previous year on the nave floor other maintenance has been identified. The flat roof of the vestry roof leaked into the Vicar's vestry causing some damage. This was repaired as a temporary measure to make it water tight but it was clear that a major flat roof replacement was necessary. A quote for £17,000 including VAT (£3,000 to be reclaimed) involving a new fibreglass roof and guttering has been received and arranging this is work in progress. Fund raising will be necessary.

Other extensive work is required when funds become available around the North and South Transept gable windows. They need taking out with the stone surrounds replaced and re-pointed but this is a major project which will cost over £60,000.

A new flag pole has been fitted in the bell tower with this being a major project as the original flag pole had rotted. Scaffolding was necessary to complete the work and ARCO Uk experts in safety kindly funded this for us. ARCO also provided a Fall Arrest Safety Harness System for our use (usually by Paul with myself supporting) when working at height to raise or lower the flag at the top of the tower.

Remaining with health and safety over the last 2 years there has been a full health and safety assessment on all the headstones in the three sections of the grounds. A traffic light system of risk was applied supported by a health and safety manager and friend of the church. Work parties arranged by Paul using the resources of 'The Regiment' (men's group) worked with our groundsman, to make those in the Red category safe with further sessions planned later this year on others.

Our extensive churchyard always needs attention and Colin our groundsman does a great job. Every Autumn members of 'The Regiment' form a work party to cut back and tidy up as required. This is a terrific day of fellowship with wonderful refreshments provided by our ladies from the vestry.

Teamwork None of the above could have been achieved without the strong team of volunteers we have in the parish. A very grateful 'thank you' goes from me to all those who work so hard in varied roles to support services, play the organ, read, prepare intercessions, arrange flowers, provide refreshments, clean the church, lock and unlock St Mary's, meet and greet or simply support me as church warden in other ways.

This year the remodelling of the Church has really revealed its usefulness in adapting to the needs of very different users and activities. It is now established as a community use building.

The Greek and Cypriot Orthodox Church use of the building on two Sundays a month ensures that it is in use for Christian services every Sunday.

Many thanks to Elizabeth and Stephen for hosting 'Home at Church' on the third Sunday.

Thanks to Tom and Aimée who have offered to help with music during the vacancy.

The Thursday communion service continues to be well attended and the coffee and chat sessions in the Narthex have become a thoroughly enjoyable social event. Thanks to everyone who assists with this activity. Your help is very much appreciated. The Knit and Natter group also enjoy their Thursday meetings in the Narthex. Many thanks to Julie for this.

The Ladies prayer group also held their meetings in the Narthex on Thursday afternoons before moving to Julie's Tea Room to make way for another group to use the Church. I am sure that the café's cakes have been much appreciated by the group.

All Saints' hosted a very successful and well attended Alpha course in conjunction with Revive Church. Excellent refreshments were provided by a hard-working team.

Bumps and Babies has become a very strong group, thanks to its excellent team, providing a warm welcome for children, parents and carers. It provides an opportunity for parents and carers to socialize, make contacts and develop friendships at a time when the demanding needs of childcare can be very isolating.

The Coffee Mornings on the first Thursday have become a hugely enjoyable and well attended event thanks to the excellent and hard-working team of ladies. Thanks also to the many people who have contributed delicious cakes. So many people have commented on the beautifully warm and relaxed atmosphere during these mornings and the uplifting sound of people simply enjoying being together. The generous donations made at these events reflect people's appreciation and directing these gifts to charities establishes us as a generous Church.

The Christmas Fayre/Christingle Service was an excellent event successfully combining fun activities and worship. Again, the success was due to the numerous people who contributed their time and effort. Many thanks to all those involved in the organization.

The excellent floor space at All Saints was perfect for staging an enjoyable Barn Dance. Thanks to everyone involved for the terrific effort they put into organizing this successful event.

All Saints proved to be an excellent venue for a large event, the Fashion Show. It didn't quite manage to rival Paris, but it was a great success and enjoyed by all. Thanks to everyone involved.

The Pancake Party was another enjoyable and very successful event. It provided a much-needed social gathering at what can sometimes be a difficult time of year for some. Again, thanks to all involved. Your efforts are much appreciated.

With St Mary's Church Hall being damaged and out of use for the present, All Saints has provided accommodation for: Monday's Keep Fit Class, the WI's third Monday meeting, Wednesday's Brownies and Rangers, Thursday's Community Painting Class.

A busy year for All Saints' in which it extended its role as a place of worship to also becoming a venue for social events for church members and the wider community. We can look forward to this role expanding in the future.

Ecumanism Mick Fryer

Hunsley Christian Youth Trust

As a Benefice we continue to support HCYT who now buy in the services of a Christian worker, Adam, who works for Label of Love. He works mainly in South Hunsley School doing one-to-one support work, but also takes assemblies in Elloughton Primary School.

Hunsley Churches Together

We continue to have a very strong relationship with Elloughton URC sharing a Lent Course and jointly running 1St Sunday Praise. Most events/groups draw in support from local churches. The annual Week of Prayer for Christian Unity saw us joining with St.Helen's Welton, URC, Revive Church and the Methodists as well as being together for our Good Friday service. 2022 also saw us supporting Revive Church with two Alpha Courses in our Brough building.

Knit & Natter Julie Branton

The knit and natter group continues to meet on the last Thursday of each month. Numbers are still very low but we enjoy the company of each other and helping and learning from one another. Over the last year we all contributed to the knitting and crocheting of angels which were displayed for the schoolchildren at Christmas and we are now working on crosses to be given out at the three churches at Easter. Watch this space for the new venture of choirboys for next Christmas! Apart from this we continue to work on our own projects. We would be delighted for anyone with any craft project, or none, to join us for fellowship

The 1st Sunday Lunch continues to thrive-we are now in our 5th year!

We average 12-14 people each month and we meet in the Half Moon Pub.

Initially this was developed as it was noted that many parishioners were leaving church to go home, to cook and to eat alone most Sundays.

Whilst we only meet once a month we are grateful for the fellowship and friendship we gain from each other.

Coffee Mornings at All Saints' Church

The first coffee morning was held to celebrate the Queens Platinum Jubilee on 2nd June. This was very well attended with all 3 churches being represented.

Prosecco, home-made cakes and coffee and lots of chat were enjoyed by all.

Due to this success, it was decided albeit on a much smaller scale, to hold a monthly coffee morning after the morning service of Holy Communion at All Saints' on the first Thursday of each month (and without the prosecco!)

We commenced in July and the coffee mornings are proving very popular with numbers steadily increasing each month.

We work on a donation basis and so far have raised over £1,000 for our chosen charities which include Macmillan, Children's Society and the Full View Project at Jubilee Church.

The coffee morning team also helped to organise and run the Christmas Fayre and Christingle in December

The Men's Breakfasts Mick Fryer

For the past year a group of men have continued to meet on the 2nd Saturday of every month for breakfast, Bible study and fellowship. We tend to average 10 blokes each time as there are always a few who can't make it. The group is made up of men who worship at all three of our churches as well as Elloughton URC, Revive Church and beyond! It makes for a great mix and lively discussion.

Each breakfast of bacon rolls & drinks, lasts one hour and starts at 8.00am and is hosted by different members of the group, new men are always welcome, so check the Pew Sheet for venues.

This last year has seen us add the URC building to our venues with Paul cooking and Barry hosting and then some of us stay on for a game of Table-Tennis, a great addition! Not a church group but the 'Regiment', organised by Paul Shepherd, continues to grow in membership. We meet monthly in Welton Social Club and now also have a monthly walk on a Saturday morning. Both of these groups are open to any men who want to join us.

Brough Bumps and Babies Group.

This group has now been running for almost two years.

Our attendance has been gradually rising and we now have over 50 on our list with a regular attendance each week of over 20.

The group has been led by myself with help from Mick Fryer, Elizabeth Mitchell, Jean Reynolds, Angela Greaves, Sally Millerand Sue Mansell. An addition to the team this year have been a group who look after the refreshments -Jean Towns, Sandra Kinroy and Pat Wilkinson.

We have quite a high turnover of parents as they attend the group when the babies are tiny and then most often return to work, so we lose them within about 6-9 months. We have been encouraged by the number who stay in contact through our Facebook group and sometimes drop in on sessions when they are not at work.

We meet for an hour, each week with toys for the babies and toddlers and coffee, chat and biscuits for the parents. We end the session with 5 minutes singing and rhymes

We gained a grant from the Atkinson Foundation in March which meant we were able to buy a small soft play slide, some soft cubes and a larger ball-pool. Treasurer's Report

Elloughton cum Brough PCC for Year to 31st December 2022

Summary

2022 saw a return to normal levels of activity. A number of major projects were completed which has significantly depleted our cash reserves.

Income

Voluntary income was up by £5,000, with giving up and granting income also increasing. There were Grants of £4,600 from the List Places of Worship Grant scheme, and £750 from the Atkinson foundation for Tiny Footsteps and Bumps and Babies. We also received a grant of £1,250 to help with energy costs.

Expenditure

Total expenditure in 2022 has been unusual with the repairs to floor at St Mary's (£24,900) and the refurbishment of the Church Hall toilets (£25,600). Renewing the flat roof over the toilet kitchen and Office at All Saints' was an unexpected but necessary additional expenditure of £7,200.

Administration cost are down as we have managed without an Administrator for most to the year.

Generous Churches

The PCC had pledged freewill giving to the Diocese of £15,000 in 2022, the full amount was paid. This contribution however needs to increase if we are to cover the full cost of the ministry we receive from the diocese.

All Saints Brough Developments

The final invoices for this work have been paid.

Investments

The PCC holds 2,999.15 shares with the CCLA with a year-end value of £61,920.15. £10,000 worth of shares were sold to contribute to the cost of major works. The fund value has fallen due to the adverse economic situation.

The PCC has cash balances of £ 1,270 in a CCLA Deposit account, and bank balances in the current and savings account stand at £6,336 and £1,077, respectively.

Other writings and notes

The large increases in energy costs have so far only had limited impact as we have fixed price contracts in place for gas and electricity. We will see an increase in electricity costs next year and in gas from 2024 onwards. The cost of heating oil used at St Mary's doubled from £380 to £750. Stephen Mitchell (Treasurer)
